- Warm-ups:** AM Warm-ups start at 8:00am - Meet starts at 9:00am  
PM Warm-ups not before 12:00pm- Meet Start approx 1:00pm
- Eligibility:** **ALL SWIMMERS MUST BE YMCA MEMBERS**
- Entries:** **ENTRY DEADLINE: FRIDAY, NOVEMBER 6TH, 2009**
- Each swimmer may compete in up to **four (4)** individual events plus **two (2)** relays.

- Entry Fees:** \$3.00 for each individual event, \$10.00 for each relay.

- Seeding:** The meet will be pre-seeded.
- Awards:** Ribbons will be awarded by **Each Age Group** (8&U, 9-10, 11-12, 13-14, SENIOR) 1<sup>st</sup>-16<sup>th</sup> place finishers.
- Clerk of Course:** There will be a Clerk of Course for 8 & Under swimmers. The Clerk of Course will be staged near the pool and swimmers will be escorted into the pool area. Swimmers for all other events should report directly to their assigned lanes.
- Concessions:** Food, beverages and snacks will be available for purchase throughout the meet in the concession area.
